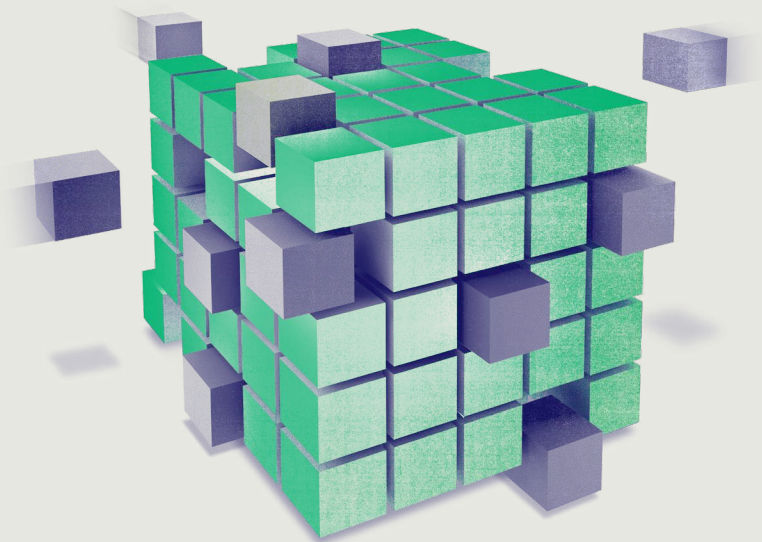


Expression of Interest Northern Territory Government Boards and Committees

Overview Expression of Interest - NT Government Boards and Committees

Northern Territory Government (NTG) boards and committees play an important role in good governance by providing independent and expert governance or advice. They provide an effective link between government and the community.

Appointments to NTG boards and committees are approved by the Minister responsible for the relevant legislation, or in some cases, the Administrator of the Northern Territory. Legislation generally outlines any specialist qualifications required of members.
